

GUIDELINES FOR MINOR VOLUNTEERS  
 EXPERIMENTAL AIRCRAFT ASSOCIATION  
 (ACCORDING TO WISCONSIN'S CHILD LABOR LAW)

Youth 14 to 18 years of age can participate with written parental consent but must adhere to the following conditions

**Minors of any age:**

- Cannot operate a motor vehicle on a public road on a regular basis.
- Cannot operate, set up or clean meat and food slicers
- Cannot operate power-driven saws, guillotine shears or power-driven hoisting equipment.
- Cannot do any work in a confined space or in excavation involving a trench more than 4 ft. deep
- Cannot work on, or about, a roof

**Minors under 16:**

- Cannot work with ladders/scaffolds more than 6 ft. in height
- Cannot work on or near a landing strip, taxiway or maintenance apron
- Cannot operate powered equipment (lawn mowers, snow blowers).
- Cannot operate any power tools.
- Cannot work in construction including demolition and repair.
- Cannot operate or tend hoisting equipment.
